

**EXPRESSION OF INTEREST (EOI) FOR PURCHASE OF BAMBOO DUST FROM
ABRPL**

Assam Bio Refinery Private Limited (**ABRPL**) is a joint venture company incorporated with three promoters viz: Numaligarh Refinery Limited (A Public Sector Undertaking of Govt. of India) along with two other foreign companies Fortum and Chempolis from Finland.

ABRPL is coming up with a bamboo based 2G Bio Refinery where Ethanol will be produced along with other platform chemicals like Acetic Acid, Furfural and Bio coal. ABRPL is located adjacent to Numaligarh Refinery Limited, Dist. Golaghat, Assam and has been registered on 04/06/2018 with its registered office at G.S.Road, Guwahati.

ABRPL invites interested parties to express their interest for the “**PURCHASE OF BAMBOO DUST FROM ABRPL**”.

BRIEF SCOPE OF WORK:

1. Introduction: Bamboo chips of approx. 20-25 mm or 1 square inch is the main raw material for operating Bio Refinery. During the production of chips from raw bamboo, bamboo dust is generated which has almost the similar composition as the bamboo chips. Bamboo dusts are separated from the chips to maintain uniform size in the biorefinery digester feed.

2. Availability: Total Bamboo dust – Approx. 20000 tons per annum.

3. Points of Availability:

- i. Raw Bamboo Handling Unit inside ABRPL plant and
- ii. Local Level Entrepreneur’s (LLE) chipping unit location spread across Central and Upper Assam, Arunachal Pradesh, Nagaland and Meghalaya. Production of approx. 450 tons per annum per LLE chipping unit.
- iii. Districts of LLE locations:

5. Collection and Transport facility – Bamboo dust from collection points located inside the plant or LLE chipping units. Dust collected shall be transported through Road transport by abiding all rules and regulations.

6. Sizes of the dust – Less than 2 mm.

The Bamboo dust generated will be useful for the following range of industries-

1. Particle or Mill Board manufacturers.
2. Cheap grade of writing and printing papers
3. Moulding & Decorative purposes
4. Additives filling for composite plastics, panels etc.

6. Any other relevant / innovative industry
