

EXPRESSION OF INTEREST (EOI) FOR PROVISION OF TRANSPORTATION SERVICES AT ABRPL, GOLAGHAT, ASSAM

Assam Bio Refinery Private Limited (**ABRPL**) is a joint venture company incorporated with three promoters viz: Numaligarh Refinery Limited (A Public Sector Undertaking of Govt. of India) along with two other foreign companies Fortum and Chempolis from Finland.

ABRPL is coming up with a bamboo based 2G Bio Refinery where Ethanol will be produced along with other platform chemicals like Acetic Acid, Furfural and Bio coal. ABRPL is located adjacent to Numaligarh Refinery Limited, Dist. Golaghat, Assam and has been registered on 04/06/2018 with its registered office at G.S.Road, Guwahati.

ABRPL requires around 5 lakh tons of raw bamboo annually which is intended to source from Central and Upper Assam and from the adjoining border districts of Arunachal Pradesh, Nagaland & Meghalaya.

ABRPL invites interested parties to express their interest for the “**PROVISION OF TRANSPORTATION SERVICES AT ABRPL, GOLAGHAT, ASSAM**”, from the aforementioned sourcing areas of Assam.

BRIEF SCOPE OF WORK:

- 1. General description:** There are two types of materials to be transported – Bamboo Poles and Bamboo Chips. The material characteristics and logistics requirements are enumerated as follows:

2. Planning for the truck's placement at respective contracted routes in accordance with the monthly plan.
3. Provision for providing the centralised fleet movement visibility during the trips through GPS/telematics device integrations.
4. Provision for the requisite fleet, manpower, maintenance etc. for seamless operations.
5. Capability to handle the daily operations through the ABRPL defined platform using mobile app/laptops/computer systems to receive, respond and interact for daily transportation indents.
