

Purpose of EOI

Assam Bio-Ethanol Private Limited (ABEPL) intends to invite Expression of Interest (EOI) from interested Domestic/International buyers of acetic acid and furfural which is being produced at the bio ethanol plant being developed by ABEPL at Numaligarh, Assam.

About Assam Bio-Ethanol Private Limited (ABEPL)

Assam Bio Ethanol Private Limited (ABEPL or Company), is a Joint Venture (JV) Company between Numaligarh Refinery Limited (NRL), Chempolis OY, Finland and Fortum 3 B.V. Netherlands. The Company proposes to produce eco-friendly bioethanol, acetic acid and furfural/furfuryl alcohol from bamboo biomass. The project targets at larger production of sustainable biofuels in India to reduce India's dependence on imported petroleum. The biorefinery will be based on Chempolis' 2nd generation bio-refining technology, which enables selective fractionation of biomass and co-production of multiple products in a sustainable way.

In 2008, Government of India announced its national policy on Biofuels mandating a phase wise implementation of the program of ethanol blending in petrol in various states to the tune of 5%. However, due to shortage of ethanol, the program hadn't had much success. Learning from the past experiences, demand & supply status, government has revamped the program and has come out with National Policy on Biofuels – 2018, wherein an indicative target of 20% ethanol blending in Petrol is proposed by 2025. Moreover, the government is encouraging production of ethanol derived from multiple feedstocks, second generation ethanol technologies and its commercialization.

Methodology of Empanelment

Parties or customers, who are willing to buy Acetic Acid and Furfural on Ex-Works/FCA/CFR basis without any deviation/enhancement requirement from Assam Bio-Ethanol Pvt Ltd (ABEPL), shall be empaneled. The future tender/offers for acetic acid & furfural shall be called among the empaneled parties. ABEPL reserves the right to reject any or all the offers without assigning any reason thereof. Eligibility Criteria

Buyers who have traded/consumed a minimum quantity* of 50MT/Annum of Chemicals in any 2 calendar years of the previous 3 calendar years preceding this EOI would be eligible for empanelment. The buyer shall submit the following documentary proof for the same.

 Copies of Export/Import invoice or Bill of Lading copies indicating the name of the applicant either as a trader or as a final consumer.

*The quantity shall exclude intercompany transactions (within same group companies) and paper transactions.

Empanelment

After scrutiny of the application, the eligible applicants will be notified regarding their nomination in the empanelment list. Empanelment shall be made every year in the months of April and October. All the empanelment requests received during the year shall be evaluated accordingly in this bi-yearly window.

Once empaneled, the extension of the empanelment period shall be automatic till ABEPL decides to review empanelment of a particular buyer.
